The parent assumes the district's responsibility of transportation for the 2021-2022 school year including but not limited to this agreement.

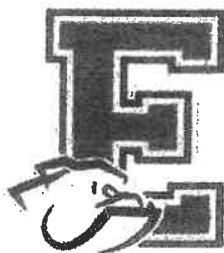
