VI. LEGISLATIVE LIAISON

Mr. Schymanski reported on the following:

Federal Legislation

Build Back Better legislation on Pre-School. I checked into the proposed legislation to see how or if it applied to Elida. If approved, the Pre-school money goes to an LEA and to any local Head Start program. Money cannot be utilized to support a for-profit or church-based pre-school. I'm not sure that if this bill is approved, Elida will see any benefit. But it could perhaps lower or eliminate the money we pay the ESC for preschool services.

Democrats are still locked into an internal battle over the Build Back Better bill. This is stalling needed action on the 12 required budget bills and the need to address the debt ceiling. One of the 12 required bills contains education funding, and it would be nice to have a funding bill with, hopefully, an increase in both Title and IDEA funding. A Title funding increase would help us address reading deficits. IDEA funding increase would help reduce the extra \$10,000 average per pupil cost of Special Education students that is absorbed by our local taxpayers.

Ohio Legislation

HB126, a bill that would require a resolution by any public entity when initiating a challenge on a property tax value or counter a proposed business reduction request. There is a concern that the bill will include text to eliminate school boards from the entire process. I did submit written testimony to oppose this bill. There is another hearing on Tuesday (11/16). I don't plan to submit testimony for this session, but I did write Senator Huffman, to let him know

my opposition. As info, per our attorneys, we only challenge property tax revisions on business property and then, only if the tax change would result in a loss of \$20,000 or more in tax revenue.

SB229, which is titled use of blended learning for the 2021-2022 school year. The bill is more comprehensive than the title suggests. The bill was modified, and the modifications were supported by OSBA, OSABO and BASA. It seems beneficial to school systems. I will report more as the bill becomes finalized.

SB248 is a bill that would require public schools to have a moment of silence each day. This bill requires a moment of reflection, prayer, meditation, patriotic themes, or a student may choose not to participate. This will supersede other state law prohibitions.

3. Resolution to Oppose the Establishment of the Backpack Scholarship Program, as Proposed in House Bill 290 of the 134th General Assembly (11-21-3)

WHEREAS, the establishment of a statewide universal voucher program, as introduced in House Bill (H.B.) 290 (the "Backpack Bill"), would allow \$5,500 for K-8 and \$7,500 for 9-12 students to be deposited into an education savings account to be used for private school tuition, tutoring, textbooks and other allowable uses; and

WHEREAS, the Backpack Bill would repeal the EdChoice and Cleveland voucher programs, and provide \$5,500 to \$7,500 to all students, regardless of a family's income; and

WHEREAS, the cost of the Backpack Bill is being analyzed, but H.B. 290 will likely cost several billion dollars annually depending on student participation rates; and

WHEREAS, in many cases, the vouchers are awarded to student who never attended a public school; and

WHEREAS, private and charter schools are not held to the same academic or financial standards as the public schools; and

WHEREAS, from 2005 to current date, the NAEP (National Assessment of Educational Progress) scores show no difference among public, private or charter schools; and

WHEREAS, many students who receive a voucher, show a decrease in state test scores during the first three years following the transfer; and

WHEREAS, in many cases, the operators of the private/charter schools are driven by profit motives and not educational improvement; and

WHEREAS, the impact of the Backpack Bill on the future of the Fair School Funding Plan is unknown, but it would no doubt be detrimental to further phase-in of the Plan.

WHEREAS, the impact of the Backpack Bill on the future of Elida's funding is unknown and could require an unnecessary increase in the local funding share; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Elida School District, that:

Section 1. It is necessary to oppose H.B. 290 of the 134th General Assembly to ensure the full phase-in of the Fair School Funding Plan; which Plan, when fully phased-in, will adequately and equitably funds Ohio public schools.

Section 2. The Treasurer is authorized to deliver or cause to be delivered a certified copy of this Resolution to community leaders; to members of the Ohio House of Representatives and the Ohio Senate, including Representative Bob Cupp and Senator Matt Huffman; and to the office of Governor Michael DeWine.

Section 3. This Resolution shall be in full force and effect immediately upon its adoption.

4. Employment of Substitute Teachers (11-21-4)

WHEREAS, the Elida Local School District Board of Education ("Board of Education") has experienced difficulty obtaining substitute teachers during the 2021-2022 school year amidst the ongoing COVID-19 pandemic; and

WHEREAS, pursuant to authority granted in Section 4 of Senate Bill 1, which was enacted by the 134th General Assembly and became effective as an emergency measure on October 28, 2021, the Board of Education may establish its own education requirements for individuals to serve as substitute teachers in the District during the 2021-2022 school year; and

WHEREAS, the Board of Education desires to temporarily adopt modified education requirements for substitute teachers in accordance with the law during the current school year as a measure to help ensure availability of a sufficient number of substitute teachers; and

WHEREAS, non-bachelor degree substitute teachers must provide evidence of at least earning a high school diploma, be of good moral character, has provided a BCI/FBI criminal background check that is less than one year/365 days old, and has applied/received a 1-year Temporary Non-Bachelor's Substitute Teaching License issued by the Ohio Department of Education in order to serve as a substitute teacher under the temporary rule.
